Counselor In Leadership Training C.I.L.T. (Entering Grades 10 through 12)

CILTs receive basic counseling instructions and disciplines from the Directors, Administrative Aides and Senior Counselors while working with their group for the summer. Their experience, training and accomplishments are recorded and are often used for future references. Tuition is not required for this position. CILTs receive remuneration for their work during the summer. Applications are available through our website or office and should be completed and returned to apply and begin the educational interview process of obtaining employment. Eight week CILT applicants will take precedence over non eight week applicants.

A \$250.00 registration fee is required with each application and is not refundable or transferable.
Monthly payment plans are available with balances paid by July 1st. Contact our office for more information.
Tuition includes transportation using bus stops locally located to campers's address.

Additional Enrollment Information:

Transportation and/or Extended Hours is included in Tuition. Transportation is offered from and to one bus stop only, within designated areas and routes. Additional bus stops may be requested and arranged at additional charges.

Morning and Afternoon Snacks included.

Optional Catered Lunch program is available.

Prices on this price sheet supersede all previously published price sheets. Programs, prices, activities and inclusions are subject to change without notice.

All Facilities will be closed, **July 4th & 5th** for observance of the national holiday.

Guest Fees - \$175.00 per day for one time only.

3/4 Day Dismissal (1:30 PM) is available to all 3 - 4 year old campers. There is no reduction in tuition for selecting 3/4 day dismissal.

All campers must have independent bathroom skills and be fully potty trained to attend camp.

Less than 5 day or full day enrollments may restrict the activities campers receive. We do not guarantee campers will receive all activities when less than 5, full day enrollment is selected.

We reserve the right to make price or enrollment changes without notice.

Adjustments To Tuition:

Sibling Discount: A 5% discount will be available for each additional family member enrolled for a 7 - 8 week session. A 3% discount will be available for each additional family member enrolled for a 4 week session.

Referral Credits: A \$200.00 tuition credit is available for each 7 - 8 week 5 full day enrollment referral. A \$100.00 tuition credit is available for each 4 week 5 full day enrollment referral. (does not include family members). The referring family's name must appear on the referred camper's application, when submitted, to receive a credit.

Special discounts may be offered throughout the year. Contact our office for details of any current offerings.

Financial Policy: We offer the following information in order to avoid any misunderstanding or embarrassment.

Enrollment Cancellations: Prior to, April 30: 100% of any tuition paid is refundable or transferable. After April 30th: a \$50.00 re-processing charge is applied. Changes made in enrollments after May 15th will incur a \$50.00 reprocessing fee. Enrollment registration fees are not refundable or transferable.

All tuition, unless prior arrangements exist, must be paid in full by May 1st. If payment is not received by May 1st, any early enrollment discount received will be forfeited and tuition will be charged at current published rates. A camper may not begin camp before the account is paid in full. Credits are not available due to weather or emergency camp closures. There will be no reduction or reimbursement for absence for any reason.

Increased or decreased enrollments after June 1st of the present season will be billed at the current tuition rate including any discounts, if any, in effect at the time of enrollment change. No financial adjustment for decreased enrollment is available after June 1st.

Enrollments, made for space available after April 30, are payable in full at the time of the application unless prior arrangements exist. A late processing fee equaling \$100.00 will be added to published tuition for enrollments received after April 30, 2024.

A \$35.00 charge will be made for each check returned for non-sufficient funds. Following a second non-sufficient funds check, only a bank check or money order will be accepted for payment.

Past due service charges on the unpaid balance after May 1st are \$25.00 per month.
